Alfred Hansen moved the two added items be accepted for the Agenda; Louis Lallier seconded. Motion Carried

APPROVAL OF 2019 AGM MINUTES AS DISTRIBUTED: The 2019 AGM Minutes were distributed via email and at the AGM. Mary Holley moved to accept the minutes as distributed. Russell Mercer seconded. Motion carried.

TREASURER'S REPORT: Mary Holley gave reporting on the AHPA Financials and copies were distributed at the meeting. Revenue, expenses and other items were reported pertaining to AHPA funds. The balance in GICS and bank accounts were reported, and the complete financial statement will be posted in the Fall Newsletter. Any member who would like to have a copy of the Treasurers Report can receive one from Mary. Mary moved that the Financial and Treasurers Report be accepted, approved as presented. Alfred Hansen seconded; Motion carried.

BUDGET: Mary Holley presented Draft budget for 2021 and 2022 and as required by AGLC must balance every two years. Several assumptions were required to be made for the draft budget.

AHPA 2020 Treasurer Report

As of August 31, 2020, the AHPA is in an unusual position. The future is impossible to forecast.

The income for 2020 was near normal but expenses were greatly reduced with no tournaments and no travel. 2021 however could see the AHPA lose some of the normal sources of income.

The 2019 casino revenue deposited in February of 2020 was \$67260.60. Although the next casino should be in the 4th quarter of 2021 it will likely not be until the 2nd or 3rd quarter of 2022.

AB Sport Connection issued grants according to previous schedules, however, they have advised that how we report members is not acceptable. Associate members are not to be counted in our totals. Currently, they are still allowing us to count students from the high school programs. The membership for this year is down so much that we may lose our grant from ASC.

Expenses for 2020 were down in the areas of tournament added prize money because the Provincials and the AB Open were cancelled. Travel, both in –province and out-of-province was down by about \$14,000 because travel paid out in September and October of 2019 was for travel actually completed in July and August of 2019, thus the previous fiscal year.

AGLC has suggested that the 24 months to spend casino revenue could be extended but that the use of proceeds will not be changed unless it relates to COVID-19 requirements.

AHPA 2021 & 2022 Draft Budget

The drafts presented balance every two years as required by AGLC.

In compiling these two years budget the following assumptions have been made:

1. That the AHPA will have a casino and receive those funds in the 2022 fiscal year

2. That AB Sport Connection will continue with grant money with our greatly reduced membership numbers in 2020 and the disallowing of counting associate members

3. That the membership will support the AHPA in fund raising to host the Canadians in 2022

4. That tournament attendance improves from 2019 when tournaments resume

5. That AGLC continues to approve out of province travel

6. That the Provincials, AB Open and Memorial tournaments are held where travel is within the \$2000 per tournament amount

7. That the newsletter be put on the web and no longer printed and mailed out. I have allowed limited funds for postage and newsletter.

8. Bank fees will not increase.

9. Accounting fees will not change. When the AHPA has to contract with a different accounting firm the cost of the annual notice to reader will be at least triple.

Notes:

The money in the Tournament account can only be used for prize money for the Provincials, AB Open, Memorial and the Western Canada Classic when in Alberta. Money deposited to this account comes from entry fees and donations from individuals, clubs and the AHA general account as per the budget.

The Canadians accounts are restricted to use for hosting the Canadians. These funds have been accumulated from the end of the last time AHPA hosted in 2014 when the balance was \$10567. This means only \$4405.51 has been raised in over 6 years.

The Casino accounts income is from Casinos (usually every 24 months) and any donations from other AGLC funded organizations. All funds must be spent according to the current Use of Proceeds. All funds used for out-of-province travel must be pre-approved by AGLC. All funds spend from the Casino account are reviewed annually by AGLC where they check invoices, receipts and bank and accounting records.

The General account income is from AS Sport Connection grant, membership fees, sales of game related goods, silent auctions and donations. Zone 3 Report

October 2019-2020

This has been historic year, which I am sure everyone would agree, we could have done without.

The CHC held regular league play Tuesday evenings and Thursday afternoons until March 16 2020. At that time CHC executive discontinued all league and tournament play due to COVID 19. Regular league play resumed outdoors July 2 and resumed indoors Sept 1 with strict adherence to COVID 19 Guidelines.

The CHC hosted the following Tournaments since the last AHPA Meeting:

- A one day tournament on Oct 4 2019 with 15 player attending. 4 from other zones.
- The Nov 16.17 2019 scheduled tournament was canceled because of bad weather.
- A one day tournament January 18 2020 with 15 players attending. 4 from other zones
- A one day tournament February 15 2020 with 19 players attending. 7 from other zones
- A one day tournament February 16 2020 with 16 players attending. 4 from other zones

All tournaments where canceled from March 16 2020 until October 2020

It is hoped the regular league play and hosting of tournaments will continue from this point on.

Several CHC members participated in the backyard tournament hosted by Tom Moffatt who I believe

deserves the gratitude of all participants as this had to have been a lot of work.

The CHC has made major improvements to the indoor play area. The old asphalt floor had become uneven due to tree root from the neighboring property owned by Univar Canada. CHC approached Univar regarding the problematic trees and the company agreed to remove the offending trees at their expense.

Many discussions on floor replacement had taken place prior to 2017. The floor was put in place in 1986, so a 30 year life expectancy would put the floor replacement requirement at 2016.

When Don Wilby was elected president of the CHC in 2017 he soon got the ball rolling to look into getting the floor repaired or replaced. A Grant committee consisting of Don Wilby, Mary & Mike Holley, Jim & Dianne Beck & Gail Aker was established to look into of acquiring financial assistance from the City of Calgary. The initial application based on a study by IBI Group of building and site deficiencies, to improve Site Drainage on North asphalt parking lot and south side of the building as well as Full playing area and pit reconstruction was rejected by the City in October 2018. The city representatives recommended the Calgary Horseshoe Club provided a detailed technical report to support the full floor replacement. The club requested Jim Beck to prepare this report to be presented to the city. The CHC was informed Feb 14, 2020 that the Capital Conservation Grant (CCG) application with the City of Calgary was successful in securing city funds for the project. Total funding approved by the city was \$266,695, CHC was approved for \$200,021 (75%). The construction contract was awarded to CANA Construction Mar 20, 2020 with actual construction commencing Apr 22 (delayed due to Covid -19). The floor construction was completed under budget in July.

This project would not have been accomplished without the dedication of CHC volunteers.

First and fore most the club members owe a huge debt of gratitude to the executive members who worked countless hours on seeing the project to a successful completion.

A big thank you to Mike Holley, Sid Aker who did a lot of the heavy lifting waterproofing the pits, and installation of the pins and backboards. Robb Lallier painted the lines on the floor and the end walls in the play area and the bar. Many other dedicated volunteers were involved in removal and replacement of all material from the playing area. This work was ongoing throughout July and August.

Other improvement to the club.

Most of the interior has been repainted thanks to volunteers.

Installation of new windows and a security gate in the bar area.

The kitchen fire suppression system was brought up to current code requirements. New lines were paint in the outdoor playing area. Thanks to Leo Coninx.

That about covers most of the goings on at the CHC since the last AHPA meeting.

The CHC hopes everyone has an opportunity to enjoy our renewed facility.
