ITEMS TO BE ADDED TO AGENDA: Mike advised to add the Purchase of a new Canadian flag to travel between tournaments under New Business.

ACCEPTACE OF AGENDA WITH ADDITIONS: Mary moved to accept the agenda with the additions. Darla Lallier seconded. Motion carried.

MINUTES OF 2022 AGM MINUTES: The 2022 AGM minutes were distributed via email to all members and at the meeting. Rhod Hubbard moved to accept the 2022 AGM minutes as presented. Ed Michel seconded. Motion carried.

TREASURER'S REPORT: Mary Holley presented Treasurer's Report.

Carstairs Accounting Services completed a Compilation of Financial Information for the 2023-2023 year. As of August 31, 2023, the assets included in RBC chequing accounts, RBC GICs, inventory of horseshoes and other game related items and prepaid expenses (insurance).

Total Cash: \$31,307; GICs \$172,272 – these funds are general and restricted. Restricted funds include those restricted by AGLC and those internally restricted by AHPA:

Revenue: Casino \$74,492, Grant from SPAR: \$14,311; Game Related sales \$1740

Tournament entry fees: \$7470, silent auction at Provincials and WCC \$523. Other revenue from interest on GICs and the disbandment of Lacombe Horseshoe Club.

Expenses: Major expenses: Bursaries: \$10,000; donations to clubs: \$9000; travel assistance \$34,054, insurance and accounting fees: \$2218.

Grant from SPAR was decreased because in three previous years the AHPA had not spent enough money, would not accept that there were no tournaments due to COVID.

AHPA is in a solid financial position at this time.

Darla moved to accept the Treasurer's Report as presented: Doris Winfield seconded; Motion carried.

Question from Wes Walker regarding what does the insurance cover. It covers the trailer and contents and if AHPA is sued for any reason, covers hiring a lawyer. Sport related injuries your provincial medical plan would cover. Mary explained that she does a rider for Olds, Innisfail and Red Deer on the insurance to cover these tournaments. Advised Wes that the Strathmore Ag Society may have a similar insurance.

BUDGET REPORT- Mary Holley presented Budget Report.

The budget document shows actuals for 2019- 2023. It also shows the changes made to the 2023 budget from what was approved at the last AGM to what was approved at a general meeting in June 2023. The last 2 columns show the draft budget for 2023-24 fiscal year and the 2024-25 fiscal year.

As AHPA has a casino in January of 2024, the funds will be deposited in May. Expenses show several increases. Affiliation fees to Horseshoe Canada have increased from \$2 per player to \$5 per player.

The AHPA should plan to purchase more portable courts in the spring of 2024.

Travel assistance for tournaments both in-province and to the Western Canada Classic, Canadian Championships and the World tournament has been increased to reflect the rapidly increasing cost of travel. This is to help encourage players to attend more tournaments. Out-of-province travel must still be approved by AGLC for each tournament.

Estimated costs of redeveloping the web site are included again in 2024 as this has not been completed.

I have dropped expenses for executive meetings as they can be held at tournaments where players receive travel assistance, or they can be held via zoom.

At the time of the budget preparation, I do not know where the Western Canada Classic will be held in 2025. If AHPA is the host, then additional costs will be incurred for prize money and awards.

This budget is balanced every two years as per AGLC requirements. Mary moved to approve and accept the Budget Report as presented. Louis Lallier seconded. Motion carried.

CORRESPONDENCE REPORT & SECRETARY REPORT: Gail Aker presented.

A thank you letter from Don Wilby, President, Calgary Horseshoe Club for the \$1000 donation from AHPA to promote the Calgary Horseshoe Club.

Letter from Cindy Ekkel, President of the Wetaskiwin Horseshoe Club that their club will be folding at the end of the Year. The club thanked AHPA for their continued support as they had hosted some past yearly tournaments.

OLD BUSINESS

Doubles – Jane Cordingley

At the last General Meeting, Dave Burrows asked if there was a possibility to have doubles at the Fall Memorial Classic as it was in the past and this question was brought forward to the AGM.

Jane Cordingley advised that a doubles tournament was held in Red Deer with 6 teams, she matched up high/low. She has advised that Horseshoe Master has the capability of handling. Jane will devise a score sheet as each player's ringer will have to be scored.

The other questions are a different form, entry fee, prize money and travel. AGLC will have to be approached for approval for any funds used for travel.

2023 Canadians- Jane Cordingley

Held in Guelph, ON and it was a good tournament even with the rain, that is another reason to strive to only be held indoors. 127 players with 10 players from AHPA.

Western Canada Classic – Jane Cordingley

This tournament was held at Calgary Horseshoe Club with 27 players, 19 from AB: 6 from Saskatchewan and 2 from BC. Good tournament.

2024 Western Canada Classic and Canadians will be held in Abbotsford, BC

NEW BUSINESS

Change of membership structure- Mary suggested eliminating some categories, far too many and if you are a member of AHPA, then you are a member no matter what your age, player or not.

Increase in Membership fees- Mary moved the AHPA membership fees be increased to \$20.00 per person and the same fee for everyone. Jane seconded. Motion carried.

Discussions: HS Canada cannot sustain at \$2.00 so their fees are now \$5.00. Fees pay for H.C. membership, insurance, etc.

Mary also advised that with the casino used for travel, awards, trophies but AGLC put guidelines on how the money is to be spent.

Membership List – AHPA and Eshoe. Jane advised on the different uses of these two programs. With Eshoe the results are recorded directly into the program and is much easier to complete. However, it appears it only goes back one year and not previous years. Jane will investigate.

Revised Bylaws: Gail Aker

The Revised Bylaws were presented via email and at the AGM meeting and all the members present reviewed. Gail made a motion to accept the revised bylaws and present under Special Resolution along with the Society Return to the appropriate Alberta Government department. Darla Lallier seconded; Motion carried.

Special Committees to recruit/retain. Requested volunteers to head up a committee. Don advised that in 10 years, 70% of membership will be 80+. Any ideas or suggestions please pass them on to any of the executives. Need to make better use of Facebook and other social media outlets. Mike Holley handles the school kid programs coming to Calgary Horseshoe Club and he is hoping to arrange an interschool tournament. Wes and Dean from Strathmore are going to be doing a marketing blitz over the winter.

Additional roles for VPs- as neither Vice President nor the member who suggested were not at the meeting this has been tabled until the next AGM.

Give Away- presented by Gail Aker. Cindy Ekkel emailed some score boards, etc. for give away to any club who would like to have. Get in touch with Cindy.

New flag: Mike Holley moved to purchase a suitable Canada Flag to be taken to each Alberta sanctioned tournament. Mike amended the motion to include the Alberta Flag as well. Ed Michel seconded. Motion carried.

Hosting of 2024 AHPA AGM

Don Wilby made a bid proposal for the Calgary Horseshoe Club to host the 2024 AHPA AGM on Saturday, October 5, 2024. No other proposals were received. Darla seconded; Motion carried.

Alberta Sponsored Tournaments Proposals – open for two days.

Provincials: Don Wilby made a bid proposal for the Calgary Horseshoe Club to host the Provincial Tournament on June 29 and 30, 2024. No other bids, Calgary awarded.

Alberta Open: Don Wilby made a bid proposal for the Calgary Horseshoe Club to host the AB Open on May 18 & 19, 2024. No other bids, Calgary awarded. These dates are new as in the last 2 years this tournament has been cancelled. Darla seconded.

Fall Memorial: Don Wilby made a bid proposal for the Calgary Horseshoe Club to host the Fall Memorial on September 21 & 22, 2024. Gary Bartholet seconded. Calgary awarded.

AHPA Sanctioned Tournaments – Jane Cordingley

The meeting turned over to Jane to address the assignment of the AHPA Sanctioned Tournaments and all these tournaments will be posted in the Fall Newsletter.

MEETING TURNED OVER TO NOMINATION CHAIRPERSON

Mike Holley advised if you want to nominate anyone for a position, make sure that person is agreeable to run for election.

Second Vice President for a term of 2 years.

Dave Burrows is the incumbent, and he has advised he will allow his name to stand.

Winnona Kilbourn also advised allowing her name to stand for the position.

Voting by ballots: Dave Burrows elected

Treasurer for a term of 2 years.

Mary Holley has held this position for a long period of time, and she will not be running for re-election at this time. Mary nominated William Steveson. No other candidates were nominated.

William Stevenson was elected by acclamation.

President- for a term of 2 years.

Jackie Olmstead has decided not to run for re-election at this time.

Alberta Horseshoe Pitchers Association Treasurers Report 2023



Carstairs Accounting Services completed a Compilation of Financial Information for the 2022-2023 year.

This is the process that replaces a Notice to Reader.

As of August 31, 2023 the assets included cash in RBC chequing accounts, RBC GIC's, inventory of horse shoes and other game related items and prepaid expenses (insurance).

The total cash was \$21,307 and GIC's were \$172,272. These funds are general and restricted funds.

Restricted funds include those restricted by AGLC and those internally restricted by AHPA.

Revenue

The majority of revenue comes from casino in the amount of \$74,491 and a grants from Sports, Parks and Recreation of \$14,311. Of the balance game related sales were \$1740, tournament entry fees of \$7470 (all paid out in prize money & scorekeeping fees) and the silent auction at Provincials and WCC raised \$523. Other income included interest income from GIC's and a donation from the Lacombe Horseshoe Club when it disbanded.

Expenses

The major expenses this past year were bursaries (\$10,000), donations to clubs (\$9000), travel assistance to players travelling to tournaments (\$34,054), insurance (\$2218) and accounting fees.

The grant from Sports Parks and Recreation was decreased because in the 3 previous years the AHPA had not spent enough of their funds. They would not accept that we did not have any tournaments for 2 year due to COVID as a valid reason for not spending a sufficient percentage of the funds. That problem has been rectified in 2023.

The AHPA is in a solid financial position, at this time. Some of the travel expenses overlap each year, and that was the case again this year. The budget will provide more information about the future of AHPA.

Notes to Compiled Financial Information Year Ended August 31, 2023

BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the statement of financial position of Alberta Horseshoe Pitchers Association as at August 31, 2023, and the statements of revenues and expenditures, changes in net assets and cash flows for the year then ended is the historical cost basis and reflects cash transactions with the addition of:

- Accounts receivable less an allowance for doubtful accounts;
- Inventory is valued at the most recent purchase price;
- Property, plant and equipment, goodwill are recorded at historical cost and amortized on a declining balance method;
- Accounts payable and accrued liabilities
- Revenues are recognized when services are complete and invoiced;
- Inventory purchases are recognized when inventory is received.

2. PURPOSE OF THE ORGANIZATION

Alberta Horseshoe Pitchers Association (the "organization") is incorporated under the Society's Act of Alberta as a not-for-profit organization and is a registered charity under the Income tax Act. The association aims to promote and improve horseshoe pitching in Alberta.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Government grants

Government grants are recorded when there is a reasonable assurance that the organization had complied with and will continue to comply with, all the necessary conditions to obtain the grants.

Inventory

Inventory is valued at the lower of cost and net realizable value with the cost being determined on a first-in, first-out basis.

Alberta Sports and Recreation Report 2023

In August of 2023, the AHPA received an installment of our grant from Alberta Sports. The amount was for \$,900.00 The amount of this grant was increased from the previous installment that we received in the spring due the resumption of expenditures and tournaments that we were unable to do during the covid mandates. Please note that these funds we receive from Alberta Sports are based on the number of players within out organization. As well, there is criteria these players must meet to be counted.

I am currently working on completing the next Annual Survey. Section one is due the end of October. This survey requires the birthdates, city of residence, gender and postal code of our members. No names are shared. Participation in the AHPA and their club is also requested (eg volunteer, judge, coach). Questions regarding coaching, training and programs we offer are also asked.

The second part of this survey is due the middle of February next year. This section requires the listing of our executive and directors, our annual AGM meeting minutes, an annual report as well as out strategic business plan. Our policies and procedures are only required if changes or additions occur.

AHPA Membership Report 2023

Hello to everyone. Our overall membership decreased in 2023. This was mainly due to many Alberta horseshoe players not reregistering as there were no Interprovincial or Canadian tournaments being hosted in our province this year.

Our membership in 2023 consisted of 135 playing members and 40 nonplaying members, bringing the total to 175 AHPA members. Of these, 11 new players joined our association, two of whom were women and 9 of whom were men.

When sharing the membership numbers with Alberta Sports for our grant, they are specifying that they only require the number of playing members rather than the total number of members as in previous years.

Kudos to the horseshoe clubs who encourage schools to bring out their students to learn how to pitch horseshoes. These numbers are not included in the playing numbers but are taken into consideration by Alberta Sports.

In closing, I am hoping that the AHPA will be able to not only maintain but to increase our numbers in our organization in the upcoming 2024 season.

2023 Tournament Directors Report

This year was another challenging year for tournaments held by the AHPA.

The Provincial Championships attracted 24 players, from which we crowned our 3 class champions. Cal Beaudoin in the Mens, Lindsay Hodgins in the Ladies and Gary Bartholet in the Elders class.

TRAVEL ASSISTANCE FROM AHPA 2024

Please read the following guidelines carefully. As AHPA members, please help make every event fun and successful.

World Tournament assistance will be for players only based on the following criteria:

- 1. Must complete 4 AHPA sanctioned tournaments (1 of which must be the Provincial Championships) These tournaments must be between Sept 1, 2023 and the date you leave for either Abbotsford, BC or Tri-Cities, Washington.
- 2. Must submit a completed itinerary to William Stevenson by noon May 15, 2024.
- 3. Must travel to and from Tri-Cities by the most direct route or compete in the Canadian Championships in Abbotsford and use the most direct route from home to Abbotsford and then to Tri-Cities and back home.
- 4. Must complete the tournament.
- 5. Fuel or airfare receipts must be submitted. Please attach fuel receipts on an 8 ½ x 11 sheet of paper in date order. Car rental and fuel for rental must have receipts and submitted.
- 6. The number of nights' accommodation will be approved as per AGLC rules. There is a maximum of \$150 CDN per night.
- 7. Payment will be based on receipts submitted after travel that meet the approval of AGLC and fit within the AHPA budget.
- 8. All receipts must be attached to an 8 $\frac{1}{2}$ " x 11" sheet of paper with tape unless the receipt is an 8 $\frac{1}{2}$ " x 11" paper.
- 9. All claims with receipts must be to the treasurer by August 23, 2024.

Canadian Championships and Western Canada Classic assistance will be for players only.

- Must compete in 4 AHPA sanctioned tournaments (1 must be the Provincial Championships)
 These tournaments must be between Sept 1, 2023 and the date you leave to travel to Abbotsford, BC.
- 2. A completed itinerary must be submitted to William Stevenson by noon May 15, 2024.
- 3. Must travel to and from Abbotsford by the most direct route. If traveling to the Canadians and then the World Tournament, please contact William Stevenson for additional information and criteria.
- 4. All fuel or airfare or car rental receipts must be submitted.
- 5. The number of nights accommodation will be approved as per AGLC rules. The maximum per nights is \$150.

- 6. The claim forms will be provided at the end of the tournament.
- 7. Payment will be based on receipts submitted after travel that meet the approval of AGLC and fit within the AHPA budget.
- 8. All receipts must be attached to a sheet of paper that is $8 \% \times 11$ ". Do not hi-lite on the receipts. It will not photocopy. Remember all receipts are submitted to AGLC for review.
- 9. Players must complete the tournament they enter to qualify for the claim.
- 10. All claims with receipts must be to the treasurer by August 23, 2024.

Provincial Championship, AB Open and Memorial will be treated as in-province travel as in previous years.

- 1. 2 nights accommodation (maximum of \$150 per night). Some exceptions may allow 3 nights.
- 2. Fuel based on receipts.
- 3. Completed claim forms submitted by deadline of June 8 for the Alberta Open, July 15 for Provincials, and September 30 for the Memorial with all receipts attached to an $8 \% \times 11$ sheet of paper.
- 4. Players must travel the most direct route to and from the tournament.
- 5. Players must complete each tournament that they enter.
- 6. The minimum of 100 km. has been eliminated from the travel assistance policy.
